**Cofnodion Cyfarfod Misol Cyngor Cymuned Llandysul Community Council a gynhaliwyd yng Nghanolfan Ieuenctid Llandysul, ar 13eg Mehefin 2016**

**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Llandysul Youth Centre, on 13<sup>th</sup> June 2016**

Roedd PCSO Shan Davies yn bresennol yn y cyfarfod a hysbysodd y Cyngor o'r digwyddiadau canlynol a fu yn Ardal Llandysul yn ystod y mis diwethaf

- 1 achos o Ddifrod Troseddol yn y Stryd Fawr, a oedd yn cynnwys ceir preswylwyr, ac maent yn gwybod pwy yw'r unigolyn cyfrifol.
- Lladrad yn Spar Llandysul – arestiwyd rhywun, ond nid ydynt yn rhywun lleol
- Y bwriad i ddefnyddio beic modur sy'n cynnwys gwn mesur cyflymdra yn y pentref ac ym Mhren-gwyn

Dywedodd Cyng Gethin Davies bod tystiolaeth sylweddol ym Mharc Pont-siân bod pobl yn yfed yno, a bod defnyddwyr y parc wedi dod o hyd i boteli o alcohol. Cytunodd PCSO Shan Davies ymchwilio i'r mater.

PCSO Shan Davies was present at the meeting and informed the Council of the following incidents that has occurred in the Llandysul Area in the past month

- 1 incident of Criminal Damage in the High Street involving resident's cars, person responsible has been identified.
- Theft in Spar Llandysul – arrest made but not a local person
- The intention of bringing a speed gun bike to the village and Prengwyn

Cllr Gethin Davies pointed out that there was significant evidence in Ponsian Park of people drinking where bottles of alcohol have been found by park users. PCSO Shan Davies agreed to look into the matter.

- 2 **Datgelu Buddiannau/Declarations of Interest** Gwnaeth y Cynghorwyr canlynol ddatgelu budd mewn perthynas â'r materion dan sylw, a gwnaethant oll adael y cyfarfod pan drafodwyd y pwyntiau perthnasol – Cyng Beth Davies ar gyfer Sioe Llandysul a Sioe Prengwyn a Charnifal Llandysul a Chyng Gethin Jones ar gyfer Sioe Llandysul. / There were declarations of interest from Cllrs Beth Davies for the Llandysul Show, Prengwyn Show and Llandysul Carnival and Gethin Jones for Llandysul Show and all left the meeting at the relevant points.

cyfarfod. / Minutes of monthly meeting held on 9<sup>th</sup> May was accepted as correct and signed following adding Cllr Roy Davies as present at the meeting.

### **Materion yn Codi:-**

**Goleuadau Nadolig** – Roedd Cyngorwyr Tom Cowcher, Wyn Evans ac Andrew Howell wedi cwblhau'r gwaith o archwilio gosodiadau'r goleuadau presennol a'r gost o'u huwchraddio. Hysbyswyd y Cyngor bod angen 900 metr o oleuadau er mwyn disodli'r rhai presennol. Y gost fyddai £556 fesul 100 metr. Penderfynwyd y byddai'r clerch yn cael caniatâd perchennog Bryntawel ac y byddai angen 38 metr o oleuadau. Penderfynwyd y dylai'r clerch gysylltu ag Ann yn Llandysul Pont Tyweli Ymlaen er mwyn cael gwybod o ble y daeth y goleuadau yn wreiddiol.

### **Matters Arising:-**

**Christmas Lights**– Cllrs Tom Cowcher, Wyn Evans and Andrew Howell had concluded the scrutiny of the currents light fixtures and costs of upgrading. The Council were informed that 900meters of lights was needed to replace the current ones. The cost would be £556 per 100meters. It was decided that the clerk obtain permission from the owner of Bryntawel and 38meters of lights would be needed. It was decided that the clerk contact Ann from Llandysul Pont Tyweli Ymalen to ascertain

where the lights had originally come from.

**Leisure Centre** – The Clerk to resend the email received from Mr Darryl Evans to all members.

**Llandysul Aqua Centre** – It was noted that the County Council had signed over the land to the trustees of the Pool on the 7<sup>th</sup> June 2016

**Personal** A letter was received from Cllr Wyn Evans informing the Council of his decision to retire as Councillor following our next meeting on the 11<sup>th</sup> July 2016. The Chair thanked him for all his hard work during his time as Councillor and stated he would be missed.

**Crime Commissioner** It was decided to write to Dafydd Llywelyn inviting him to one of our meetings.

**Chairmas Allowance** Cllr Keith Evans had decided on donating his Chairman's Allowance for 2015-16 Municipal Year as follows, £100 each to the Memorial Park, Llandysul Cubs and Scouts and Llandysul Aqua Centre. It was decided that the clerk write a letter to all the individual organisations.

**Llandysul Show** - £800 was requested from Llandysul Show to help with the costs of introducing a craft tent to the show. It was decided to donate the requested amount.

**River Festival** – A request from the Llandysul Paddlers Canoe Centre Ltd for £2000 for help with running the Annual River Festival. As the festival brings a lot of money to the local economy it was decided to donate the requested amount.

**Memorial Park** Cllr Keith Evans explained that he would be picking up the commemorative plaque the following day. A cheque to be written for the requested amount. He also reported that Ken Bowen had explained that some extra work needed to be done when building the wall in order for everything to be tidy for about £150. It was decided to proceed.

#### **Children's Play area**

The clerk to check with ROSPA regarding the annual checks.

It was decided that Cllr Abby Reid continues with ordering the signs for the play area.

It was also noted that there were no lids on the litter bins in the play area. It was decided that the clerk contact the Youth Centre as they had created bins with lids in the past.

#### **Ward Matters**

Cllr Abby Reid explained that the Give Way sign on the junction turning towards Pencader was missing. It was decided that the clerk contact Carmarthenshire County Council.

**Pontsian/Capel Dewi** – Cllrs were reminded of Gwyl Fawr Capel Dewi that is to be held and also of the concert and open day at Pontsian School before it closes its doors in July.

**Llandysul** It was decided that the clerk write to the County Council with regards to Rhiw Gof and thank them for the resurfacing work and ask if they reinstate the white lines on the back roads as there are no Give Way lines.
