1 **Ymweliad/Visit** –

Roedd PCSO Siân Davies yn bresennol yn y cyfarfod er mwyn adrodd am ddigwyddiadau yn Llandysul dros y mis diwethaf.

- Nid oedd unrhyw ddigwyddiadau i'w hadrodd yn ystod y nosweithiau a gynhaliwyd gan Sioe Llandysul a digwyddiad Dragon Fest yng Nghroes-lan.
- Bu un achos o fandaliaeth yn Heol Llynyfran Llandysul a hefyd, un achos o ddifrod troseddol yn hen Siop Daphne Jones.
- Adroddwyd bod offer fferm wedi cael ei ddwyn yn ardal Pont-siân ond nid oes unrhyw beth pellach i'w adrodd am yr achos hwn ar yr adeg hon.

Diolchodd y Cadeirydd i PCSO Siân Davies am fynychu ac am ei hymroddiad rhagorol tuag at sicrhau bod ein Cymuned yn lle mwy diogel.

PCSO Sian Davies was present at the meeting reporting on recent incidents in Llandysul over the past month.

- There had been a nasty assault in Bradford House, Llandysul and two people had been kept in remand.
- There were no incidents to report on the nights of the events staged by Llandysul Show and Dragon Fest at Crosllan .
- One case of vandalism had occurred on Heol Llynyfran Llandysul and also one case of criminal damage at the former Daphne Jones Shop.
- An incident of theft of Farm equipment has been reported in the Pontsian area but there was nothing further to report at this time.

The Chairman thanked PCSO Sian Davies for her attendance and excellent dedication to making our Community a safer place.

2 **Datgelu Buddiannau/Declarations of Interest:** Gwnaeth Cyng Keith Evans a Tom Cowcher ddatgelu budd yn Llandysul Pont Tyweli Ymlaen. Cllrs Keith Evans and Tom Cowcher declared and interest in Llandysul Pont Tyweli Ymlaen.

3 **Adroddiad y Cadeirydd/Chairman's Report**

Adroddodd y Cadeirydd, Cyng Keith Evans, ei fod wedi cynrychioli'r Cyngor Cymuned mewn digwyddiadau amrywiol dros y mis diwethaf. Gwobrau Arwyr Lleol Radio Ceredigion yn Aberystwyth, lle y gwnaeth y barbwr lleol, Mari Slaymaker, ennill gwobr Entrepreneur. Yn ogystal, roedd Cyng Evans wedi cael gwahoddiad gan Gybiau a Sgowtiaid Llandysul i gyfarfod gyda dros 100 o gynrychiolwyr a wnaeth fynychu Jamborî y Byd yn Japan mewn aduniad a gynhaliwyd yn safle Padlwyr Llandysul.

Nododd Cyng Evans hefyd ei fod wedi mynychu'r Pencampwriaethau Ceufadu Prydeinig a gynhaliwyd yng Nghanolfan Padlwyr Llandysul yn ddiweddar, ac y gofynnwyd iddo gyflwyno'r gwobrau. Aeth ymlaen i esbonio bod Pencampwriaeth Geufadu Cymru wedi cael ei chynnal yn ystod yr un penwythnos hefyd. Roedd hi'n braf gweld bod cymaint o Badlwyr ifanc Llandysul wedi bod yn amlwg iawn yn ystod y ddau ddigwyddiad.

Aeth ymlaen i ddweud wrth y Cynghorwyr am y budd economaidd aruthrol y mae digwyddiadau o'r fath yn ei gynnig i'r dref a'r cyffiniau. Er mwyn cynnig lle i nifer sylweddol yr ymwelwyr a ddaeth i'r digwyddiadau, bu pobl yn aros mewn gwahanol lety hyd at 20 milltir o Landysul.

Esboniodd hefyd, o ganlyniad i natur frys cais a wnaethpwyd gan Llandysul Pont tyweli Ymlaen i ddefnyddio maes parcio y Cyngor Cymuned gyferbyn Neuadd Tysul ar noson y Ffair Nadolig a gynhelir yn Llandysul, ei fod wedi ceisio caniatâd y Cynghorwyr mewn ffordd electronig. Gwnaethpwyd penderfyniad unfrydol i ganiatáu'r cais a chafodd hyn ei gadarnhau yn ystod cyfarfod y Cyngor.

Yn ystod y cyfarfod diwethaf, gofynnwyd i'r Cadeirydd osod torch yn ystod gwasanaeth Sul y cofio ym mis Tachwedd, ac i wneud darlleniad hefyd. Roedd y ficer wedi anfon y darlleniad at y cler, ac roedd y cler wedi ei anfon ymlaen at Gyng Keith Evans. Yn ogystal, gofynnwyd am rodd tuag

at Apêl y Pabi. Gan gadw at y traddodiad a'r arfer, penderfynwyd y byddai'r Cyngor yn rhoi £50 i Apêl y Pabi ac y byddai'r Cadeirydd yn cymryd rhan yn y Gwasanaeth.

Chairman, Cllr Keith Evans reported that he had represented the Community Council at various events during the past month. Radio Ceredigion's Local Heroes awards in Aberystwyth where local barber Mari Slaymaker, won the Entrepreneur award.

Cllr Evans had also been invited by Llandysul Cubs and Scouts to meet with over a 100 representatives that had attended the World Jamboree in Japan at a reunion staged at Llandysul paddlers.

Cllr Evans also reported on his attendance at the recent British Kayaking Championships that was held at the Llandysul Paddlers Centre and where he had been asked to present the awards. He further explained that the Welsh Canoe Championship had also taken place over the same weekend. It was gratifying to witness that so many young Llandysul Paddlers featured strongly at both events. He went on to tell Councillors of the enormous economic benefit that such events bring to the town and surrounding area. In order to accommodate the significant number of visitors to the events accommodation was sought up to a 20 miles radius of Llandysul.

He also explained that due to the urgency of a request made by Llandysul Pont tyweli Ymlaen for use of the Community Councils car park opposite Tysul Hall on the evening of the Christmas Fair in Llandysul, he had sought the consent of Councillors by electronic means. It was unanimously agreed to allow the request and this was ratified and confirmed at the Council meeting.

In the last meeting a request had been made for the Chairman to lay a wreath during the remembrance service in November and to also read a lesson. The vicar had sent the reading to the clerk which had been duly forwarded to Cllr Keith Evans. A request had also been made for a donation towards the wreath and Poppy Appeal. It was decided that, in keeping with tradition and practice that the Council would donate £50 to the Poppy Appeal and that the Chairman would participate at the Service.

One Voice Wales Conference Cllr Andrew Howell had represented the Community Council at the conference. He explained that Leyton Andrews had spoken on the view of where Town and Community Councils might be going in the view of changes to County Councils. Nothing would be changing prior to May 2016 elections. Two more speakers spoke in the afternoon which were more focused about more responsibility coming to Town and Community Councils.

Esboniodd hefyd ei bod wedi cytuno cyfarfod gydag Ymddiriedolwyr y Parc ynghylch llwybrau cyllid, ac y byddai'n adrodd yn ôl yn dilyn y cyfarfod hwn.

Public Footpaths– An email was received from Nigel Nicholas reporting that work on both footpaths were being progressed.

Bus Shelter in Capel Dewi – A quotation had been received from Abacus Cleaning regarding repairing the Bus Shelter. It was decided to seek further quotations from Gethin Davies and Rhodri Thomas.

Branches and Hedges – The clerk had contacted the County Council regarding the hedge on Seion Hill. She had also asked County Councillor Peter Evans for help in resolving this problem.

Budget Challenge – Cllr Roy Davies had attended the event in Llandysul. He explained that he was given a questionnaire to complete. Cllr Abby Reid explained that she had completed the questionnaire online. The Chairman thanked them for their participation.

Ageing Well Ceredigion – a response had been sent to Ceredigion County Council.

Course - Cllr Abby Reid had been to a course at the Welsh Audit Office. She explained that it had been most informative and that she had found more avenues for self-funding and other ways of raising capital. She also explained that she had agreed to meet with the Park Trustees regarding avenues of funding and would report back once this meeting had taken place.

Road Closures – It was decided that the clerk write to the County Council asking them to provide better and advanced information as to the exact location of closure. The councillors explained that the road closure in Pontsiân was very poorly signed.

Mark Williams MP – More notices of contact details were received and distributed to members for displaying on our Notice Boards.

(i) Fireworks an application form was received from Llandysul Scout Group asking for a donation of £500 to help with the cost of the community firework display. Cllr Andrew Howell proposed and Cllr Carolyn Reid Rees seconded that we support the event. All agreed.

Parc Coffa/Lle chwarae i blant – cafwyd llythyr gan Ymddiriedolwyr y Parc Coffa. **Cynllun Budd Cymunedol yr Ysgol 3-19** Esboniodd Abby Reid ei bod hi wedi cael cyfarfod gyda Lisa Garfield o Wilmot Dixon ar 22 Medi. Dywedwyd wrthi eu bod wedi cael ceisiadau am waith gan y Clwb Criced a'r Pwll Nofio, yn ychwanegol i'r gwaith a gynigiwyd ar gyfer y lle chwarae i Blant yn y Parc coffa. **Lleoliad y Plac Coffa** Esboniodd Cyng Keith Evans ei fod wedi ymweld ag Emyr Williams a'i fab i drafod eu cynnig ynghylch cyflenwi plac coffa gwenithfaen. Nid oeddent mewn sefyllfa i gynnig eu gwasanaeth ar hyn o bryd o ganlyniad i bwysau gwaith. Penderfynwyd y byddai Cyng Keith Evans yn nodi enwau contractwyr eraill ac yn ceisio dyfynbrisiau am y gwaith wedi'u seilio ar y dyluniadau a ddarparwyd gan Gyng Terry Griffiths. Maint y plac fyddai tua 3 troedfedd x 2 droedfedd x 11/4 modfedd. Darparwyd lluniadau gan Gyng Keith Evans wedi'u seilio ar osod y plac ar wal gerrig neu ffrâm dur. Penderfynwyd symud ymlaen gyda'r nod o'i osod yn y wal gerrig. Byddai Cyng Keith Evans yn ceisio dyfynbrisiau am y gwaith hwn, gan adrodd ar hyn yn ystod y cyfarfod nesaf. Roedd Cyng Wyn Evans wedi argraffu rhywfaint o wybodaeth gan Gymdeithas Hanes Llandysul, a oedd yn nodi'r geiriad ar y plac gwreiddiol.

(ii)Llandysul a Pont Tyweli Ymlaen Cyf - Cllrs Keith Evans and Tom Cowcher left the room whilst the matter was considered.

An application for £600 was requested to support with the cost of organising a Christmas Fair in Llandysul on 20 November 2015. It was decided to support the application and ask for a copy of their balance sheet for the event be sent to the Community Council as soon as possible post event.

5) **Matters for discussion**

Memorial Park/Childrens play area – a letter was received from the Memorial Park Trustees. **3-19 School Community Benefit Scheme** Abby Reid explained that she had met with Lisa Garfield of Wilmot Dixon on 22 September. She was told that they had also had requests for work by the Cricket Club, Swimming Pool as well as the works proposed for the Children's play area in the Memorial park.

Location of Memorial Plaque Cllr Keith Evans explained that he had visited Emyr Williams ai fab to discuss their proposal for supplying a granite commemorative plaque. They were not in a position to offer their services at present due to pressure of work. It was resolved that Cllr Keith Evans identify other contractors and seek quotations for the work based on the designs provided by Cllr Terry Griffiths. The size of the plaque would be approximately 3ft x 2ft x 11/4 inches. Cllr Keith Evans provided illustrations based on setting the plaque into a stone wall or steel frame. It was resolved to proceed on the basis of incorporating it into the stone wall. Cllr Keith Evans would seek quotations for this work and report to the next meeting. Cllr Wyn Evans had printed some information from Llandysul History Society which gave the wording from the original plaque.

Play Area A letter had been received from Paul Arnold of Ceredigion County Council stating that they would cease managing the Play Area from 1st November 2015. It was decided that the clerk arrange that insurance would be in place by the given date. The price of the insurance from

Barnwyd bod hwn yn gam cadarnhaol a blaengar yn lle'r arfer presennol o orfod delio gyda 3 endid pan fydd cwynion yn cael eu gwneud. Bydd y Cadeirydd yn cysylltu gydag Ymddiriedolwyr y Parc ynghylch y mater, gan baratoi manyleb ar gyfer y contract o gynnal a chadw y tir. Penderfynwyd y bydd Cyng Abby Reid a Chyng Andrew Howell yn cadw golwg ar y lle chwarae, gan adrodd yn ôl am unrhyw faterion bob mis.

Ymddiriedolwyr y Parc Coffa Eglurwyd bod Cyng Beth Davies yn cynrychioli Merched y Wawr ac mai Cyng Andrew Howell yw unig gynrychiolydd y Cyngor Cymuned. Ceir cyfle pellach i gael mwy o gynrychiolaeth ar gyfer y Cyngor Cymuned. Gofynnwyd i'r Cynghorwyr a oes gan unrhyw un ddiddordeb. Nid oes modd i unrhyw un wneud ymrwymiad ar yr adeg hon.

Materion Wardiau

Biniau Halen – Gofynnwyd i'r holl Gynghorwyr archwilio'r biniau halen yn eu hardal.

Penderfynwyd y dylai'r clerc edrych mewn hen gofnodion i weld ble mae'r holl finiau wedi cael eu lleoli, gan anfon y wybodaeth hon at bawb.

Rheolau Sefydlog – Roedd yr holl Gynghorwyr yn fodlon gyda'r rheolau sefydlog cyfredol. Penderfynwyd mabwysiadu Rheoliadau Ariannol Un Llais Cymru ar ôl i'r clerc eu haddasu ar gyfer Cyngor Cymuned Llandysul.

Cinio Nadolig – Penderfynwyd y byddai'r Cinio Nadolig blynyddol yn cael ei gynnal yng Ngwesty Porth ar 28 Tachwedd 2015. Bydd y clerc yn gwneud y trefniadau archebu gyda'r

Zurich would be at a pro rata premium of £413.25. It was also resolved that as the Community Council had responsibility for the play area (as from November 2015), and due to complaints received regarding the grass cutting and maintenance, that the Community Council would commission this work from the next cutting season. This was seen as a positive and progressive move rather than the current practice of having to deal with 3 entities when complaints arose. The Chair undertook to liaise with the Park Trustees over the matter and to draw up a specification for the ground maintenance contract. It was decided that Cllr Abby Reid and Cllr Andrew Howell maintain a watching brief of the play area and report back any issues on a monthly basis.

Memorial Park Trustees It was clarified that Cllr Beth Davies represented Merched y Wawr and that Cllr Andrew Howell was the only representative the Community Council. There is further opportunity for more representation from the Community Council. Councillors were asked if anyone was interested. At present no one was available to commit.

Ward Matters

Salt Bins – All Councillors was asked to check the salt bins in their area. It was decided that the clerk look at old minutes to see where all the bins were located and send to all.

Standing Orders – All Councillors were happy with the current standing orders.

It was decided to adopt the Financial Regulations of One Voice Wales once the clerk had adapted them for Llandysul Community Council.

Christmas Dinner – It was decided that the Annual Christmas dinner would be held at the Porth Hotel on 28 November 2015. The clerk to book with the hotel and forward menu to all Councillors.

Water Bowser – The water bowser had been returned to The Vicarage from Mr Alan Clifford. Cllr Abby Reid asked for a letter confirming that the bowser was insured by the Community Council.
