Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Llandysul Youth Centre, on 12th September 2016

Housing Enabler Elen Grantham was present at the meeting to update the Councillors on the houses they hope to build in Llandysul. She explained that at the moment they were concentrating their efforts on another site as the need for housing in Llandysul isn't so great. She urged the Councillors to ask people to put their names on the housing lists if they are looking for houses. All decisions are based on greater the need and all is evidence set. She also explained that this way it was ideal for local people with lower income to start on the housing ladder.

They also explained that there had been various complaints with overgrown hedges opposite Bro Marlais in Pontsiân and at various sites in Capel Dewi. The clerk to write to the County Council.

It was also decided that the clerk write to the County Council asking for more consideration be given when designing new link roads to include lay-bys as they are very scarce on the road from Llandysul to Synod Inn.
