Roedd y clerc wedi cael neges e-bost yn esbonio na fyddai fan GoSafe yn gallu parcio yn Stryd Cambrian. Byddai hi'n ceisio newid sifftiau er mwyn gweld beth yw'r broblem ac er mwyn iddi allu bod yno yn y bore, sef y cyfnod mwyaf perthnasol.

The clerk had received an email explaining that a GoSafe van would be unable to park in Cambrian Street. She would try to change shifts to see what the problem is and be able to be there first thing in the morning when the issue is most relevant.

Roedd Keith Henson, Swyddog Galluogi Tai Gwledig, yn bresennol yn y cyfarfod. Rhoddodd ddisgrifiad byr o'i waith ac esboniodd y cynlluniau am y darn o dir yn y Ffawydd. Mae'n gobeithio gwneud ymholiadau o ddrws i ddrws er mwyn darganfod yr anghenion tai yn Llandysul, ac anogodd pobl i gofrestru ar gyfer rhestrau aros Tai Ceredigion a'r holl gymdeithasau tai eraill, oherwydd y byddai hyn yn rhoi gwir syniad er mwyn gallu rhoi sylw i'r angen am dai fforddiadwy. Byddai modd canlyn dewisiadau niferus, megis Rhannu Ecwiti, Rhan-berchnogaeth, Rhentu neu Hunanadeiladu. Roedd yn rhannu'r farn ei bod yn bwysig penu meini prawf ac y dylid adeiladu tai ar gyfer pobl leol, a gweithio gyda'r Cyngor Cymuned i gyflawni hyn.

Keith Henson, Rural Housing Enabler was present at the meeting. He gave a brief description of his work and explained the plans for the piece of land in the Beeches. He is hoping to do a door to door enquiry to see what the housing needs are in Llandysul and urged people to put their names on the waiting lists of Tai Ceredigion and all other housing associations as this would give a proper indication to address the need for affordable housing. Numerous avenues could be pursued such as Shared Equity, Part Ownership, Rental or Self builds. He shared the view of the importance of setting a criteria and to build houses for local people and to work with the Community Council in order to achieve this.
