1) The following were received from **Ceredigion:-** **Public Consultation Meetings November / December 2013** It was decided to write to Miss Lowri Evans to inform her that not enough notice was given to inform the public of the meeting and ask if it's their intention to meet with all Community Councils in the coming future.

8) **British Legion Llandysul Area** – Cllr Terry Griffiths informed the Council that it should read Royal British Legion and that there was no longer a Llandysul Branch. He also added that Llandysul now came under Newcastle Emlyn branch. He left the meeting during this topic.

A letter was received thanking the Community Council for their support on Remembrance Sunday and asking for their usual donation to the Poppy Appeal. It was resolved to donate £50.00.

9) **Invoices:-**

(i) **Compass Office Supplies** - £455.16. Ink and paper for the clerk

(ii) **Llinos Jones** – Invoice for November translation was received in the sum of £119.45 and cheque was passed for payment.

(iii) **Abacus Cleaning Services** – Invoice was received for cleaning bus shelters for £243.25. It was noted on the invoice that the bus shelter in Horeb had a large area of graffiti one panel. As this bus shelter had been relocated by Ceredigion County Council when the road was altered it was resolved that the clerk ask the council if they would replace the panel.

(iv) **M Williams** – An invoice was received to the sum of £328 for the maintenance of Plas y Dderwen and Grass Bank adjacent to Tysul Hall.

(v) N Davies - £33 postage costs

(vi) N Davies - £192.50 broadband and phone costs reimbursement.

11 **Red Kiosks** – No further updates.

12 **Balchder Pentrefi** – It was reported that all invoices had been forwarded to Jo Shaw. It was also decided that Cllr Tom Cowcher contact her with regards to how many plaques were needed.

13 **Control of Dogs** Cllr Aled Jones reported that after a meeting of the Sports Committee it was decided to order more signage to try and keep the dogs off the playing fields. It was also decided that the clerk write to the Dog Warden to see if they could be present in Llandysul more regularly.

11 **Footpaths** Cllr Tom Cowcher reported that as a Community Council the need to maintain the footpaths with regards to the styles and gates. Work would be done by Haydn Lewis and it was requested that any problems should be reported to the Chairman.

12 **Bradford Square Toilets**. The clerk presented figures for insuring the toilets to the Council. It was decided that the Council would not be taking over the running of the toilets.

13 **Llandysul Swimming Pool** It was brought to the Councils attention that as £44,000 funding would be withdrawn from the swimming pool at Llandysul in the new Councils budget. It was also reported that the swimming pool would be closing its doors at the end of December. It was decided the clerk ask the Chief Executive of the County Council and the Council Leader to meet with the Community Council to see if anything could be done to save the facility and also to underline the problem with the park after £20,000 had been withdrawn from them. Cllr Andrew Howell would be attending the public meeting on 10 December regarding the swimming pool on behalf of the Council.

14 **Planning:** Notice of the Development Control Committee Meeting to be held on 11.12.2013 was received. The following plans were inspected, there were no objections:-
