1 **Ymweliad/Visit –**

Estynnwyd croeso cynnes i Gynghorydd John Adams Lewis, a oedd wedi ymweld â holl Gynghorau Cymunedol yn ystod y flwyddyn.

The local Police was present at the meeting to report on the recent murder in Llandysul and to offer reassurance to residents. Anyone with any questions or fears were urged to go to speak to them. It was reported that PCSO Sian Davies had worked tirelessly to allay people's fears . They also thanked the Community for their support and apologised for the length of the road closure of the high street but it was necessary.

All other aspect of crime in the Area was quiet and no further problems were reported. The Community Councillors thanked them for attending and for all their hard work.
