#### **PCSO**

Roedd Melanie Davies PCSO yn bresennol yn y cyfarfod.

Hysbysodd y Cyngor ei bod wedi bod yn gyfnod tawel iawn yn Llandysul, fodd bynnag, bu ymgais i ladrata yng Nghroes-lan, ond nid oedd unrhyw beth wedi cael ei ddwyn.

Yn ogystal, esboniodd bod aelod o'r cyhoedd yn cwyno bod ceir yn gyrru'n rhy gyflym yn Llandysul. Penderfynwyd parcio cerbyd plaen y tu allan i'w tŷ ac nid oeddent wedi gweld unrhyw droseddau gyrru yn cael eu cyflawni. Ers hyn, roedd yr Arolygydd a'r Siarsiant traffig wedi esbonio hyn iddo.

She also explained that damage had been done to Dyffryn Teifi School- more regular patrolling would be happening.

Cllr Peter Davies also asked if a one off speeding exercise could be undertaken in Pontsian. She would send the request to the traffic police.
