**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 14<sup>th</sup> July 2014**

### 1 **Ymweliad/Visit –**

Roedd yr Heddlu lleol yn bresennol yn ystod y cyfarfod er mwyn adrodd am y gweithgarwch troseddu a welwyd yn ddiweddar yn Llandysul. Hysbyswyd yr aelodau gan PCSO Shan Davies ei bod hi wedi gofyn am eglurhad gan Arolygydd yr Heddlu, a chafwyd cadarnhad na fyddai'r orsaf heddlu leol yn Llandysul yn cau.

Yn ogystal, soniodd y gallai Llandysul fod yn gynllun Golwg ar Oryrru Cymunedol, ac ar hyn o bryd, eu bod yn recriwtio gwirfoddolwyr ar gyfer y treialu yng Ngiliau Aeron. Bydd yn rhoi diweddariadau i'r aeoldau am gynnydd y cynllun. Yn ogystal, tynnwyd ei sylw at y ffaith bod pobl sy'n gadael Tafarndai gyda'r hwyr yn amharu ar breswylwyr lleol.

The local Police was present at the meeting to report on the recent crime activity in Llandysul. PSCO Shan Davies informed the members that she had clarified with the Police Inspector and that the local police station in Llandysul would not be closing.

She also mentioned that Llandysul could become a Community Speed Watch scheme, and that at the moment they were recruiting volunteers for a trial in Ciliau Aeron. She would keep the members updated on the progress of the scheme. It was also brought to her attention that people leaving Public Houses late at night were disturbing local residents.

**Neuadd Bentref Tregroes a'r Cylch Cyf** – Gofynnwyd am £10,000 er mwyn prynu Ysgol Gynradd Sirol Tregroes a gwneud gwaith adnewyddu cyfalaf hanfodol iddi.

Penderfynwyd cefnogi'r cais a chlusnodi'r cyllid yn y gobaith y bydd y cyllid arall yn cyrraedd.

**Cydnobod Derbyn Rhoddion** – Roedd Gwyl Wledig Tysul a Charnifal Llandysul yn llwyddiant unwaith eto eleni. Diolchwyd i'r Cyngor Cymuned am ei gefnogaeth parhaus.

The Aqua Centre's business plan had been received. It was decided from now on if money is earmarked for a particular project that the Council receive a progress report after a period of 6 months.

**Youth Coucil** – Following guidance from OVW regarding setting up an Youth Council it was decided that the Clerk contact the two areas stated in the email for further guidance. It was decided to put the matter on the agenda for September for any feedback.

**BDO** – The Audit form had been returned from the Auditors with no recommendations. It was passed as correct and signed by the Chairman and Clerk.

**Tregroes and District Village Hall Ltd** - £10,000 was requested to purchase Tregroes County Primary School and to undertake essential capital renovation works. It was decided to support the request and to earmark the funding in the hope that the other funding materialises.
