1 **Ymweliad/Visit –**

Roedd Iwan Cray, Comander Tân ac Achub Sirol yng Ngheredigion, yn bresennol yn y cyfarfod er mwyn trafod y gwaith da y mae'r gwasanaeth Tân ac Achub yn ei wneud. Adroddodd nad yw Llandysul yn ardal lle y gwelir defnydd/risg uchel. O blith ein 5000 o aelwydydd, adroddodd nad oes 15% ohonynt yn cynnwys synhwyrydd mwg a bod y Gwasanaeth Tân ac Achub yn ymwnaed gyda Gwasanaeth Gofal a Thrusio, sy'n darparu archwiliadau am ddim yn y cartref. Roedd y Cyngorwyr Cymuned yn dymuno diolch i'r criw lleol yn Llandysul am eu gwaith caled ac am eu holl gymorth ym mhob digwyddiad lleol. Maent yn cael eu parchu a'u gwerthfawrogi yn fawr yn y Gymuned.

Iwan Cray, Fire and Rescue County Commander in Ceredigion was present at the meeting to discuss the good work that the Fire and Rescue service was doing. He reported that Llandysul was not particularly a high usage/risk area. He reported that out of 5000 households 15% of them are not fitted with a smoke detector and that the Fire and Resuce Service involved in the Care and Repair Service which provide free household checks. The Community Councillors wished to thank the local crew in Llandysul for all their hard work and for all their support in all local events they are very valued and respected in the Community.

Trees in Maesymeillion County Councillor

Peter Davies reported that planning applications had been made to the County Council and all was in hand as Swalec and the road would need to be closed.

Banking in Llandysul The clerk had contacted Barclays regarding changing banks from National Westminster. Barclay would be charging for all cheques issued and a monthly nominal fee. It was therefore decided to stay with the National Westminster Bank. It was also decided that the clerk with guidance from Cllr Aled Jones look into the possibility of Electronic Banking.

Yr Hen Gapel, Llwynrhedowen

It was reported that work was underway with Yr Hen Gapel but as scaffolding had been erected visibility on the Rhydowen crossroads was very dangerous as visibility is very poor. It was decided the clerk write to Roger Clive Powell the address to be sent to the clerk from Cllr Peter Davies.

Lights at Plasydderwen

Following the previous meeting the clerk had asked Derwen Lighting to erect a new column and fix the lights. Since then the lights have been repaired but by a contractor that the Paddlers had employed. The Councillors were very disappointed that the Paddlers had tampered with Community Council property without consent. It was decided not to pay the invoice until Derwen Lighting check the work undertaken had been done correctly and meet with Gareth Bryant to scrutinise the bill. If possible town members would meet with Derwen Lighting on site.
