The paper discussing the closure is on the Health Board website namely Primary Care Applications Committee.

Cllr Keith Evans explained that he had arranged a meeting with County Director Peter Skitt as there were no Hub arranged for Llandysul or Lampeter which was very worrying.

Cllr Abby Reid explained that the drains at the bottom of Lon Letty and up the main street from Bradford Square were blocked, the clerk to contact the County Council.

Cllr Mike Hotson that they host a feel good Friday for people at the sports pavilion every month for people, volunteers and carers. They would be hosting a 12hr bowlathon on the 20 October at Xcel Bowl Carmarthen, all were invited to attend or sponsor.

He also explained that Arts for Wellbeing would be holding a story studio for conversations with people about their lives in Llandysul. He was also looking for any possible venues to hold the event.
