**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 13<sup>th</sup> January 2014**

### 1 **Ymweliad/Visit** –

Cyn i'r cyfarfod gychwyn, ymwelodd PC Greensmith a PCSO Siân Davies er mwyn hysbysu'r Cyngor o'r datblygiadau diweddaraf yn Llandysul. Anerchwyd y cyfarfod gan PC Greensmith, y mae wedi cael ei benodi yn ddiweddar i weithio yn Llandysul a'r ardal. Gan y bu gostyngiad o 86% yn lefel yr ymddygiad gwrthgymdeithasol a bod lefel y troseddu yn isel iawn, hysbysodd y Cyngor na fyddai cefnogaeth ar gyfer Parth dan Waharddiad yn Llandysul. Roedd Cilgwyn Arms, Gwesty Porth a Kings Arms wedi ymuno â chynllun gwarchod tafarndai ac o ganlyniad, dim ond 1 unigolyn oedd wedi cael eu gwahardd o'r tri safle. Roedd rhai gwarantau a throseddau yn erbyn y drefn gyhoeddus wedi digwydd, ond ar y cyfan, roedd lefel y troseddu wedi gostwng yn sylweddol yn Llandysul. Anogodd unrhyw un y mae ganddynt bryderon i leisio'u pryderon trwy siarad gyda'r heddlu. Penderfynwyd y dylai'r clerc ysgrifennu at Brif Gwnstabl Heddlu Dyfed Powys er mwyn diolch iddo am yr holl waith a wnaethpwyd gan PCSO Siân Davies yn Llandysul, ac am bresenoldeb yr heddlu, gan nodi'r gobaith y bydd yn parhau yn y dyfodol.

Prior to the commencement of the meeting PC Greensmith and PCSO Sian Davies visited to inform the Council of recent developments in Llandysul. PC Greensmith who has recently been appointed to cover Llandysul and surrounding area addressed the meeting. He informed the Council that as there was an 86% drop in anti- social behaviour and crime was very low there would be no support for an Exclusion Zone in Llandysul. The Cilgwyn Arms, The Porth Hotel and The Kings Arms had joined the pub watch scheme and as a result only 1 had been banned from all premises. Some warrants and public order offences had happened but on the whole crime was significantly down in Llandysul. He urged anyone with concerns to voice their concerns by talking to the police. It was decided that the clerk write to the Chief Constable of Dyfed Powys Police to thank him of all the hard work of PCSO Sian Davies in Llandysul and of the police presence and may it continue into the future
