**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Llandysul Youth Centre, on 18th December 2017**

**Ymweliad**

Roedd Aled Vaughan Owen o Raglen Dyfodol Gwledig yn bresennol yn y cyfarfod. Esboniodd bod y Loteri Genedlaethol yn cyflwyno'r rhaglen uchod mewn 8 Sir yng Nghymru er mwyn goresgyn tlodi gwledig. Dewiswyd Llandysul fel ardal yng Ngheredigion, sy'n golygu y gall Mr Owen gynorthwyo prosiectau posibl yn Llandysul dros tua 2 ddiwrnod yr wythnos am y cyfnod cychwynnol o ddwy flynedd, ac y bydd cymorth graddedig yn cael ei ddarparu dros y blynnyddoedd diweddarach. Mae'n cael trafodaethau gyda Ben Lake AS hefyd, yn ogystal â grwpiau cymunedol amrywiol eraill er mwyn codi ymwybyddiaeth o'r cynllun. Byddai ganddo tri grant bach o hyd at £750 y flwyddyn fel cyllid sbarduno er mwyn cynorthwyo grwpiau i gychwyn prosiectau.

Yn ogystal, byddai ar gael i nodi cyllid ar gyfer prosiectau penodol. Amlygwyd pwysigrwydd dwyn yr holl grwpiau yn Llandysul ynghyd i gydweithio fel cam pwysig ac annatod o'r broses o rannu a meddu ar weledigaeth gyffredin ar gyfer y dyfodol.

Roedd yn obeithiol y byddai cyhoeddiad yn cael ei wneud ym mis Ionawr 2018, a fyddai'n enwi'r holl Drefi.

Diolchodd y cynghorwyr iddo am y newyddion da ac maent oll yn edrych ymlaen i weithio gydag ef yn ystod ei gyfnod o ddarparu cymorth yn Llandysul, ac awgrymwyd y dylid ystyried cynnwys adnodd a fyddai'n cyd-fynd â gwaith y prosiect yn ystod cyfarfodydd i osod cyllidebau.

**Visit**

Aled Vaughan Owen from the Rural Futures Programme was present at the meeting. He explained that the National Lottery was rolling out the above programme to 8 Counties in Wales to combat rural poverty. Llandysul has been selected as an area in Ceredigion which means Mr Owen can support potential projects in Llandysul on the basis of approximately 2 days a week for the initial two year period with tapered support in the latter years. He is also in conversation with Ben Lake MP. as well as various other community groups to raise awareness of the scheme. He would have three small grants of up to £750 per annum as seed corn funding to assist groups to get projects underway.

He would also be on hand to assist with identifying grants for specific projects. The importance of getting all groups in Llandysul working together was highlighted as an important and integral step in sharing and having a common vision for the future.

He was hopeful that an announcement naming all the Towns would occur in January 2018.

Councillors thanked him for the good news and are all looking forward to working with him during his period of support work in Llandysul, and it was suggested that consideration be given at budget setting meetings to include a resource to compliment the project work.

## **Ward Matters**

### **Llandysul**

Lily Bryant from Llandysul Paddlers has been selected for Team GB Youth Olympics training camp, which could well mean that she will represent Team GB at the Buenos Aires games. It was decided to send her a letter to wish her well.

Cllr Keith Evans explained that he had taken three officers from the County Council around Llandysul to highlight his concerns with issues like general weeding and street cleanliness around the town, ineligible speed limit signs on Llynnyfaran Road, general litter problem, and the cutting of the saplings on County Council just before the Gorrig junction leading out from town.

The Christmas Light in Llandysul have had numerous problems since the switch on in November. It was decided that Council enquire re the potential of renewing the lights or to alternatively make a plan for a phased replacement programme over the next couple of years. It was decided that the matter be put on the agenda of the January meeting.

Cllr Abbey Reid highlighted her concerns regards some overhanging branches on a tree, which appears lifeless on the hill going out of Llandysul from Well Street and forward from the Gorrig road junction. It was decided that the clerk contact the County Council to express our concerns.

### **Capel Dewi**

Work on the bus shelter in Capel Dewi had now been completed.

### **Prengwyn**

Street Lights outside Blaenmene and Llannerch Prengwyn were reported as not working. It was decided that the clerk contact the County Council.

### **Pontsian**

It was decided that the clerk contact the relevant department in the County Council with regards to the bus shelter in Pontsian as an extra panel had still not been erected as promised.
