Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 9 July 2012

Yn Bresennol/Present: Cyng/Cllrs Tom Cowcher Mrs Eileen Curry Douglas Davies Terry Griffiths Andrew Howell Mrs Carolyn Reed-Rees a/and Cyng S/C Cllr Peter Davies.

Cadair/Chair: Mynychodd Cyng Mrs Eileen Curry y cyfarfod ar ei ffordd i gyfarfod arall, a chadeiriodd y cyfarfod am gyfnod byr er mwyn trafod Seddau Gwag ar y Cyngor Cymuned. Yna, galwodd y Cyngor ar yr Is-Gadeirydd, Cyng Tom Cowcher i gyflawni rôl y Cadeirydd/ Cllr Mrs Eileen Curry attended the meeting on the way to attend another meeting and chaired the meeting for a short period to discuss Vacant Seats on the Community Council. The Council then called upon Vice-Chair Cllr Tom Cowcher to preside as chair.

- 3 **Cofnodion/Minutes:** Derbyniwyd bod cofnodion y cyfarfod misol a gynhaliwyd ar 11 Mehefin 2012 yn gywir ac fe'u llofnodwyd gan y Cadeirydd a oedd yn llywyddu/Minutes of monthly meeting held on 11 June 2012 were accepted as correct and signed by the presiding Chair.

Daethpwyd ymlaen ag eitem "7" ar yr Agenda:-
7 **Seddau Gwag** – Yr unig ymgeisydd cymwys i'w hystyried oedd Mrs Rhiannon Ainsworth. Cynigiodd Cyng Douglas Davies y dylid estyn gwahoddiad i Mrs Ainsworth i'n cyfarfod fel Cynghorydd i gynrychioli Ward Llandysul, eiliwyd y cynnig hwn gan Gyng Tom Cowcher ac fe'i derbyniwyd. Cafodd y Cyngor gyngor gan ULIC na ddylid ystyried yr ymgeisydd arall gan nad oedd yr enw ar y rhestr etholiadol ac nid oedd wedi byw o fewn 3 milltir i'r Gymuned dros y flwyddyn ddiwethaf. Mae sedd yn wag o hyd ar gyfer Ward Tre-groes.
(Gadawodd Cyng Mrs Eileen Curry y cyfarfod ar yr adeg hon).

Item "7" on the Agenda was brought forward:-
7 **Vacant Seats** – The only applicant that was eligible to be considered was Mrs Rhiannon Ainsworth. Cllr Douglas Davies proposed that we invite Mrs Ainsworth to our next meeting as Councillor to represent Llandysul Town Ward, this was seconded by Cllr Tom Cowcher and carried. OVW advised the Council not to consider the other applicant as the name was not on the electoral list and had not lived within 3 miles of the Community for the past year. There remains a vacancy for the Tregroes Ward. (Cllr Mrs Eileen Curry left the meeting at this stage).

Cyflawnodd Cyng Tom Cowcher (Is-Gadeirydd) rôl y Cadeirydd.

4 **Materion yn Codi**:- Cafwyd adroddiad gan Gynghorwyr Tom Cowcher ac Andrew Howell am yr Hyfforddiant ynghylch y Cod Ymddygiad a gynhaliwyd gan Geredigion. Bydd y Clerc yn darparu copi o'r wybodaeth ysgrifenedig a gafwyd ar gyfer yr holl Gynghorwyr. Mae'r gwaith paentio a wnaethpwyd ar y Meinciau o safon uchel a thalwyd yr anfoneb. Nid yw'r Fainc yng Nghapel Dewi wedi cael ei phaentio eto ac ni chyflwynwyd anfoneb am y gwaith hwn. Mynychodd Cyng Douglas Davies Eisteddfod Llangollen fel ein cynrychiolydd ac adroddodd ei fod wedi mwynhau yn fawr iawn.

5 **Rhoddion (Datgeliadau – Gweler “2”)**

(i) **Eglwys Pont-siân** – (Gofynnwyd am £10,000 at y to). Cawsom ein hysbysu bod Ceredigion wedi cytuno rhoi grant o £20,000. Cafwyd trafodaeth a phenderfynwyd gofyn iddynt gyflwyno'r ffigurau eto. Yn ogystal, byddwn yn gofyn am gyngor cyfreithiol.

(ii) **Pwerdy** – Roedd y Clerc wedi gwneud ymholiadau ynghylch pwerau newydd, ac mae ffurflen ymgeisio am grant wedi cael ei hanfon ymlaen at y Pwerdy erbyn hyn.

(iii) **Canolfan Dŵr Llandysul Aqua Centre** – Cafwyd llythyr gan yr Ymddiriedolwyr yn diolch i ni am y rhodd a gawsant yn ddiweddar. Yn ogystal, roedd yr Ymddiriedolwyr yn dymuno cofnodi'r help a'r cymorth a gawsant gan Gyng Keith Evans trwy gyfrwng y Cyngor Sir a'r Cyngor Cymuned ar gyfer Pwll Nofio Glannau Teifi a'r Ganolfan Ddŵr. Cafwyd ffurflen ymgeisio am grant hefyd (gofynnwyd am £1,911 i wella gwresogi). Cynigiodd Cyng Mrs Carolyn Reed-Rees y dylid rhoi rhodd o £1,911, eiliwyd y cynnig hwn gan Gyng Douglas Davies ac fe'i derbyniwyd.

(iv) **Capel Seion** – (gofynnwyd am £3,000 at ffenestr). Cawsom ein hysbysu o'r ffaith nad oes grant ar gael gan Geredigion, fodd bynnag, penderfynwyd unwaith eto y dylid gofyn iddynt anfon cais at Geredigion.

(v) **Carnifal Llandysul** – Dathliadau Jiwbilî – Cafwyd cydnabyddiaeth derbyn rhodd.

(vi) **Y Garthen** – Derbyniwyd y dylid rhoi sic am grant o £400 tuag at gostau rhedeg yn unol â'r hyn a gytunwyd yn flaenorol.

Cllr Tom Cowcher (Vice-Chair) presided as Chair.

4 **Matters Arising**:- Cllrs Tom Cowcher and Andrew Howell gave a report of the Code of Conduct Training held by Ceredigion. The Clerk will provide a copy of the written information received for all Councillors. Benches have been painted to a high standard and the invoice has been paid. The Bench at Capel Dewi has not yet been painted or invoiced. Cllr Douglas Davies had attended the Llangollen Eisteddfod as representative and reported that he had a very enjoyable time.

5 **Donations (Declarations – See “2”)**

(i) **Pontsian Church** – (£10,000 requested towards roof). We were informed that Ceredigion have approved to give a grant of £20,000. A discussion took place and it was decided to request that the figures are re-submitted. Legal advice is also to be sought from OVW.

(ii) **Powerhouse** – The Clerk had checked re new powers and a grant application form has now been forwarded to the Powerhouse.

(iii) **Canolfan Dŵr Llandysul Aqua Centre** – Letter was received from the Trustees thanking for the recent donation. The Trustees also wish to record the help and support given by Cllr Keith Evans through the Community and County Council for the Teifiside Swimming Pool and Aqua Centre. Grant Application form was also received (£1,911 requested to improve heating). It was proposed by Cllr Mrs Carolyn Reed-Rees to give a donation of £1,911 this was seconded by Cllr Douglas Davies and carried.

(iv) **Seion Chapel** – (£3,000 requested towards a window). We were informed that a grant is not available from Ceredigion however, it was again decided to request that an application is sent to Ceredigion.

(v) **Carnival Llandysul** – Jubilee Celebrations - Acknowledgement of receipt of donation was received.

(vi) **Y Garthen** – Cheque for the grant in the sum of £400 towards running costs as previously agreed was passed for payment.

(vii) **Capel Undodaidd Pantydefaid** – Anfonwyd ffurflen ymgeisio am grant ymlaen atynt.

Cafwyd negeseuon e-bost ynghylch Hyfforddiant Ymsefydlu i Gynghorwyr Newydd, Ardal Triniaeth Ddwys – Datganiad i'r Wasg ynghylch Brechu Moch Daear, Cylchlythyr am Gyllid Allanol, Hyfforddiant am y Cod Ymddygiad, Sgowtiaid Cymru – Effaith y Sgowtiaid, Cynllun Grant Talebau Cadwch Gymru'n Daclus a Gwahodd Enwebiadau – Anrhydeddau Pen-blwydd 2013.
