1 **Ymweliad a Thraffodaeth parthed CCTV** - Mynychodd Cyng Gareth Williams o Gyngor Tref Castellnewydd Emlyn y cyfarfod. Cawsom ein hysbysu o fanylion y ddarpariaeth CCTV yng Nghastellnewydd Emlyn ar hyn o bryd ac o'r systemau sydd ar gael. Cyrhaeddodd Heddwlas Dafydd Jones yn ystod y drafodaeth ac fe ddylai 2/3 camera CCTV o ansawdd sganio da mewn dau gyfeiriad fod yn ddigonol er mwyn cychwyn y gwasanaeth. Y lleoliadau a awgrymwyd oedd Cyffordd Bradford, cyffordd D R Jones ac o bosibl, un i lawr tuag at y bont. Gofynnwyd i Cyng Gareth Williams fynychu'r cyfarfod ym mis Medi er mwyn darparu gwybodaeth am y costau. Yna, byddwn mewn sefyllfa i gael 3 dyfynbris. Visit and Discussion re C C T V - Cllr Gareth Williams from Newcastle Emlyn Town Council attended the meeting. We were informed of the current CCTV coverage at Newcastle Emlyn and were advised of the systems available. Pc Dafydd Jones arrived during the discussion and 2/3 CCTVs with good scanning quality in both directions should be sufficient to commence coverage. Suggested locations being Bradford Junction, D R Jones junction and possibly one down towards the bridge. Cllr Gareth Williams was requested to attend the September meeting to advise on costs. We will then be in a position to obtain 3 quotes. Dog fouling and vandalism was also discussed with Pc Dafydd Jones and will also be attending the September meeting.
