## **4) Funding Applications:-**

(iii) **Canoe Centre** - A donation of £1500 was requested in order to run the River Festival. It was proposed to approve the request by Wyn Evans and seconded by Tom Cowcher. It was requested that we ask the Canoe Centre to ensure that the music be kept down.

(iv) **1<sup>st</sup> Llandysul Scout Group** A donation of £500 was requested to help with the cost of 4 scouts to visit Japan and 6 scouts to visit Holland. It was proposed to approve the request by Andrew Howell and seconded by Wyn Evans.
